A Message From The President

We have so many accomplishments to be proud of! First of all, our volunteer base grows every year in every function of our United Way. The number of Volunteer Income Tax Assistance (VITA) Program volunteers increased this year by 35 tax preparers. In addition to the increased number of VITA volunteers, we experienced an increase in the number of families served at the South Texas College (STC) VITA site. STC moved their site to the Pecan campus and doubled the number of families assisted and the dollars returned to customers.

In addition to this great news, the City of McAllen Transit Department is supporting our Transportation Voucher Program dollar-for-dollar, up to \$30,000 for the next three years! We will help more individuals seek employment, keep medical appointments and access important health and human services. The benefits to thousands of families is beyond measure.

Furthermore, the Board of Directors recommended investing funds for additional grants to specific programs through the Education Council. The Education Council re-opened much needed food pantries in select school districts: Roma I.S.D., Edcouch-Elsa I.S.D., and La Joya I.S.D. The amount invested towards improving the quality of life for students in these districts is \$13,000.

Also, the United Way of South Texas implemented a United Way Youth Leadership Program in two high schools at Weslaco I.S.D. High school social workers dedicate time to encourage high school juniors to mentor high school freshmen. With facilitation from United Way staff, the mentors present topics centered around financial literacy, ethics, civic duty, leadership and volunteer opportunities. Students' activities include field trips, projects and quality time as mentors. Each high school designs a unique approach to accomplishing the same goal.

What an amazing year...and career! After 33 years of being a United Way professional, I have decided to retire. It has been a rewarding experience to work with such a dedicated Board of Directors and an amazing staff. Now, it is time to pass the gavel to the next leader and to give myself an opportunity to shift focus from work to family, friends and new beginnings. Thank you for your support!

DAY OF CARING PROJECT "FRESHSTART"

United Way of South Texas started Project "Freshstart" in 2011 to provide school supplies for high school Freshmen. Since the start of this project, UWST has invested \$211,777 for 25,600 Freshmen across 18 school districts in Hidalgo and Starr Counties. More than 180 volunteers from various companies, schools, agencies, and govt. entities gather together on one single morning to assemble the bags of school supplies.



IMPACT IN 2018

United Way of South Texas funds over 100 programs that address Health, Education, Financial Stability and Safety Net. We are the only local organization with the capacity to affect individuals from birth to end-of-life, resulting in the largest and most impactful non-profit footprint in our two-county service area. Over 220,000 residents in Hidalgo and Starr Counties benefited from a United Way-funded program in 2018:

HEALTH

\$216,786

saved in reduced prescription costs for **2,950** residents through our partnership with Familywize. Discount prescription cards are free and honored at participating local pharmacies.

15.395

individuals received free child and family violence counseling, end-of-life care family support and more.

1,813

children and adults received counseling and participated in support for alcohol or drug abuse.

FINANCIAL STABILITY

\$6.8 Million

in refunds for **4,437** families who received free income tax preparation services valued at **\$887,400**.

1,159

individuals with disabilites or other barriers to employment received employment services.

32.411

transportation vouchers distributed to individuals without transportation. Access to public transportation helps these clients attend job interviews/training, secure emergency transportation to work, receive support services, keep medical appointments, etc.

EDUCATION

36,556

youth received after-school care, homework assistance and benefited from education and career development, health and fitness, and leadership and character-building programs.

\$18,000

invested in **120** middle school students for new clothing and hygiene items.

3.300

Freshmen received basic school supplies with your support and with the help of **250** volunteers who packaged them.

SAFETY NET

35,659

referrals to residents who sought social services and help meeting basic needs.

5,544

individuals benefited from preparedness health and safety training, emergency assistance (for members of Armed Forces) and disaster services.

24,294

families experiencing homelessness and/or domestic violence received one or more of the following services: emergency shelter, hot meals, hygiene kits, transitional housing, and counseling.

Education Council – Represented by eight school districts (Edcouch-Elsa I.S.D., La Joya I.S.D., McAllen I.S.D., Mercedes I.S.D., Monte Alto I.S.D., Rio Grande City C.I.S.D., Roma I.S.D., and Weslaco I.S.D.) and 14 educators to identify crucial needs of students, offer emergency grants and fund food pantries.

Emergency Food & Shelter Program (EFSP formerly FEMA) – Administered distribution of over \$621,002 in federal funds for food and shelter programs in Hidalgo, Starr and Zapata Counties. EFSP designations vary annually depending on federal funding availability.

State Employee Charitable Campaign (SECC) – Managed employee giving campaign for RGV State employees. Raised \$196,631during the 2018 Campaign.
