Due to COVID-19, United Way of South Texas and its partner agencies are using creative methods to reach clients. The following are some examples of the free services available: Boys and Girls Clubs are providing Drive-Up food distribution for schoolaged youth and their families. In addition, they are offering an educational experience for virtual club members. Hidalgo Youth Center is providing Grab and Go Meals from 8 a.m. to noon. The Salvation Army has closed their family thrift store; however, they continue to provide shelter, Grab and Go Meals, and rental assistance to qualifying families via phone interview. Program continuous to offer counselling via phone to individuals struggling with addiction and substance abuse. Our partner agencies still play an essential part in assisting their clients and the community, and they are adjusting hours of operations as more information about COVID-19 is being released. Although the United Way of South Texas is not working from its office until completion of the shelter-at-home order, the organization continues to help its partner agencies during this time.
